THE PRESIDENT of the Specialist Chambers ("President"), noting Articles 33(1)(c) and 45 of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, Rules 77, 169 and 170(2) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Court of Appeals Panel following the issuance by Trial Panel II of the "Decision on Defence Requests for Certification to Appeal the Decision on Prosecution Motion for Admission of Accused's Statements" ("Decision Granting Leave to Appeal").<sup>1</sup>

## I. PROCEDURAL BACKGROUND

- 1. On 9 November 2023, Trial Panel II issued the "Decision on Prosecution Motion for Admission of Accused's Statements" ("Impugned Decision").<sup>2</sup>
- 2. On 27 November 2023, Messrs Kadri Veseli, Rexhep Selimi and Jakup Krasniqi filed requests for certification to appeal the Impugned Decision.<sup>3</sup>
- 3. On 19 December 2023, Trial Panel II granted Mr Krasniqi's and Mr Selimi's requests for leave to appeal the Impugned Decision, in part.<sup>4</sup> Trial Panel II rejected Mr Veseli's request for leave to appeal the Impugned Decision.<sup>5</sup>
