I. INTRODUCTION

- Pursuant to Rules 9(5)(a), 76, and 77 of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), the Defence for Mr Pjetër Shala ("Defence") hereby submits this request for a 5-day extension of the time limit to file its request for certification to appeal the Trial Panel ("Panel")'s "Decision on the Prosecution Motion for Judicial Notice of Facts of Common Knowledge and Adjudicated Facts".¹
- II. PROCEDURAL BACKGROUND
- On 14 April 2023, the Specialist Prosecutor's Office ("SPO") filed a motion for judicial notice of facts of common knowledge and adjudicated facts.²
- 3. On 11 May 2023, the Defence filed its response to the SPO Motion.³
- 4. On 16 May 2023, the SPO replied to the Defence Response.⁴
- 5. On 8 June 2023, the Panel issued the Impugned Decision.
- III. SUBMISSIONS
- 6. The Defence gives notice of its intention to request certification to appeal the Impugned Decision and requests the Panel to grant a 5-day extension of the time limit for the request for certification to appeal. Pursuant to Rule 77 of the

Rules, the Defence must submit its request for certification of the Impugned Decision within 7 days.

- 7. Good cause exists for the extension requested. The Defence at present is focused on preparing for the upcoming witnesses for the next evidentiary blocks. In addition, the Defence must also work towards competing deadlines including: (i) additional submissions to the "Defence Request for Variation of Protective Measures in Order to [REDACTED]" by 15 June 2023;⁵ (ii) a public redacted version of the "Defence Request for Admission of Items Used in Court with Witness TW4-01" by 16 June 2023;⁶ and (iii) its response to the "Prosecution application for the admission of TW4-04's evidence pursuant to Rule 153" by 19 June 2023 at 4 pm.⁷
- 8. The Defence understands that pursuant to Rule 76 of the Rules, it is obliged to request such extensions sufficiently in advance of the expiry of the relevant deadline. However, the Defence has encountered difficulties with meeting the applicable deadline following the Panel's order for additional submissions with regard to the protective measures request.
- 9. The requested extension will not cause any prejudice to the SPO nor will it delay the proceedings.
