on the Prosecution's Urgent Request for Modification of Detention Conditions**

1. Pursuant to the Decision¹ of Trial Panel II ('the Panel'), the Registrar has been ordered to take measures and to implement modifications to the conditions of detention² ('Modified Conditions') of Mr Hashim Thaçi, Mr Kadri Veseli and Mr Rexhep Selimi (the 'Three Accused'). In this regard, the Registrar provides the following update to the Panel on the implementation of the Modified Conditions.
2. The Registry has conducted a thorough analysis of the measures and modifications that require implementation by the Registrar as ordered by the Panel.³ Following this analysis, a Letter from the Registrar to the Three Accused and their Counsel ('Letter') has been prepared, which sets out the new system in place to implement the Modified Conditions.⁴ The Letter is annexed as confidential Annex 1. Annexes 2-4 contain relevant, personalised information for each of the Three Accused.
3. On 7 December 2023, the Registry provided the Letter, together with an Albanian translation, to the Three Accused and their Counsel. To ensure clarity on the new procedures, the Detention Management Unit management will meet with the Three Accused to explain the new system and answer any questions they may have on 7 December 2023.
4. Pursuant to Rule 82(4)-(3) of the Rules,⁵ this submission is filed as public, and its Annex 1 is filed as confidential, as it contains internal Registry information related to the detention function and facilities.
