THE SINGLE JUDGE,¹ pursuant to Article 33(2) of Law No. 05/L-53 on Specialist Chambers and Specialist Prosecutor's Office, hereby issues this order.

I. PROCEDURAL BACKGROUND

1. On 11 September 2023, the President of the Specialist Chambers decided to assign Judge Nicolas Guillou as Pre-Trial Judge in the case KSC-BC-2023-10,² pursuant to a notification by the Specialist Prosecutor's Office ("SPO") of the filing of an indictment against Sabit Januzi and Ismet Bahtjari ("Accused").³

2. On 2 October 2023, the Pre-Trial Judge issued the "Decision on the Confirmation of the Indictment" ("Confirmation Decision"),⁴ as well as the "Decision on Request for Arrest Warrants and Transfer Orders".⁵

3. On 5 October 2023, the Accused were arrested in Kosovo,⁶ and transferred to the

Detention Facilities of the Specialist Chambers in The Hague, the Netherlands on the next day.⁷

4. On 6 October 2023, the Single Judge issued an order instructing the SPO to file submissions on the transfer of filings relevant to the Accused from the KSC-BC-2018-01 file to the KSC-BC-2023-10 case file ("Order for Submissions").⁸

5. On 11 October 2023, the SPO filed its submissions ("SPO Submissions").⁹

II. DISCUSSION

6. Mindful of the need to make available to the Accused relevant filings and decisions in the KSC-BC-2018-01 file that have been issued prior to the Confirmation Decision in relation to case KSC-BC-2023-10, and considering that the SPO does not raise any objections as to the transfer of the filings listed in the Order for Submissions,¹⁰ the Single Judge shall order the Registry to transfer the documents listed below to the KSC-BC-2023-10 case file. 7. Furthermore, bearing in mind the ongoing nature of the investigation, as well as the fact that the SPO does not raise any objections in this respect either,¹¹ the Single Judge shall order the SPO to cross-file any future submissions related to the ongoing investigation of the Accused, including any forthcoming reports and/or requests that may follow as a result of the filings enumerated in the previous paragraph, in both the KSC-BC-2018-01 file, and the KSC-BC-2023-10 case file. The Single Judge also indicates in this regard that any forthcoming filings in the KSC-BC-2018-01 file to be cross-filed in the KSC-BC-2023-10 case file shall, in principle, retain their original classification, unless the SPO indicates otherwise.

III. DISPOSITION

8. For the above reasons, the Single Judge hereby:

- (a) ORDERS the Registry to copy and transfer, in the manner detailed in paragraph 6 of this order, the documents listed therein by Friday, 20 October 2023;
- (b) **ORDERS** the Registry to maintain, unless instructed otherwise, the classification level of each of the copied and transferred documents; and
- (c) ORDERS the SPO to cross-file, as described in paragraph 7 of this order, any future submissions related to the ongoing investigation of the Accused.
