I. INTRODUCTION

1. Pursuant to the Reclassification Order,¹ Articles 21(2) and 39(6) of the Law,² and Rules 82(3), (5), and 88(2) of the Rules,³ the Specialist Prosecutor's Office ('SPO') hereby provides written submissions on the reclassification of previous filings in case KSC-BC-2023-10,⁴ and submit its reasons for maintaining the current classifications for twelve of the filings in the case.⁵

2. This filing is submitted as strictly confidential and *ex parte* as it describes the basis for maintaining certain *ex parte* classifications. A confidential redacted version will be filed.

4.
