## I. INTRODUCTION

1. Pursuant to Rule 23(2) of the Rules<sup>1</sup> and the Order of the Single Judge Panel ('Single Judge'),<sup>2</sup> the Registrar hereby files additional information in relation to the requests for temporary release on compassionate grounds submitted by Mr Hysni Gucati and Mr Nasim Haradinaj.<sup>3</sup>

## II. SUBMISSIONS

- 2. On 6 March 2023, the Registrar requested an extension of time to file her submissions in relation to the two requests for temporary release.<sup>4</sup> The same day, the Single Judge granted the request with respect to Mr Gucati, pursuant to Rule 95(5)(a) of the Rules.<sup>5</sup>
