Pursuant to the Framework Decision,<sup>1</sup> and Articles 21(2) and (6) of the Law,<sup>2</sup> the Specialist Prosecutor's Office ('SPO') hereby provides notification of its intention to lift all standard redactions applied to 116599-TR (specifically 116599-TR-ET Part 1 RED and 116599-TR-AT Part 1 RED).
2. The SPO will disclose the unredacted versions of 116599-TR as soon as is practicable.
3. With this notification, the SPO notes that the recently filed challenges to the redactions contained in 116599-TR have been rendered moot.<sup>3</sup>
4. This filing is submitted as confidential pursuant to Rule 82(4) of the Rules.<sup>4</sup> The SPO does not object to its reclassification as public.
