I. PROCEDURAL BACKGROUND

- 1. On 9 February 2024, the Pre-Trial Judge issued the "Decision on Review of Detention of Haxhi Shala" ("Impugned Decision").²
- 2. On 19 February 2024, Mr Haxhi Shala filed the Appeal against the Impugned Decision.³
