THE PRE-TRIAL JUDGE,<sup>1</sup> pursuant to Articles 21(2) and (6) and 39(6) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, and Rule 82(5) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers hereby renders this decision.

## I. PROCEDURAL BACKGROUND

- 1. On 15 December 2023, pursuant to the Pre-Trial Judge's order,<sup>2</sup> the SPO filed submissions regarding the transfer of filings from the record of file KSC-BC-2018-01 to the record of the case of *The Specialist Prosecutor v. Haxhi Shala* (KSC-BC-2023-11) ("Mr Shala", "Case 11" and "SPO First Submissions").<sup>3</sup>
- 2. On 8 February 2024, the Pre-Trial Judge joined the case of *The Specialist Prosecutor v. Sabit Januzi and Ismet Bahtijari* (KSC-BC-2023-10) ("Mr Januzi" and "Mr Bahtijari") ("Case 10") with Case 11.4 The Pre-Trial Judge further directed the Registry to rename the record of Case 10 to *The Specialist Prosecutor v. Sabit Januzi, Ismet Bahtijari and Haxhi Shala* while retaining the case record number KSC-BC-2023-10 and to discontinue the Case 11 record.<sup>5</sup>
- 3. On 13 February 2024, the Pre-Trial Judge issued an order instructing the SPO to file submissions concerning the access rights to be granted to each accused in

reclassified ("Order").6

On 20 February 2024, the SPO filed its submissions ("SPO Second 4.

Submissions"). The Defence for Mr Januzi, Mr Bahtijari and Mr Shala (together

"Defence") did not make submissions.

II. **SUBMISSIONS** 

A. SPO FIRST SUBMISSIONS

5. The SPO proposes, inter alia, the copying and transfer of: (i) all filings and

decisions from the record of file KSC-BC-2018-01 that were previously transferred

to the case record of Case 10, into the case record of Case 11; and (ii) three

additional filings from the record of file KSC-BC-2018-01 into the case records of

Case 10 and Case 11, namely KSC-BC-2018-01/F00474, KSC-BC-2018-01/F00513,

and KSC-BC-2018-01/F00521 with KSC-BC-2018-01/F00521/A01.8 The SPO also

requests that KSC-BC-2018-01/F00474 retain its classification and indicates that it

will file a confidential redacted version of KSC-BC-2018-01/F00513 in both the file

and the case records.9

B. SPO SECOND SUBMISSIONS

6. The SPO submits that, in addition to the filings identified in the SPO First

Submissions, 10 three additional filings, including accompanying annexes, should

be transferred from the record of file KSC-BC-2018-01 to the case record of Case

10, namely: KSC-BC-2018-01/F00531, KSC-BC-2018-01/F00561 and KSC-BC-2018-

01/F00568. The SPO proposes that KSC-BC-2018-01/F00531 and KSC-BC-2018-

01/F00561 retain their current classification of strictly confidential and ex parte and

to file a confidential redacted version of KSC-BC-2018-01/F00568 after its transfer

to the case record of Case 10.11

7. The SPO further submits that all confidential filings in the case record of Case

10 that are available to both Mr Januzi and Mr Bahtijari should also be made

available to Mr Shala. 12 Likewise, it submits that all confidential filings in the case

record of Case 11 should be made available to Mr Januzi and Mr Bahtijari, with

the exception of KSC-BC-2023-11/F000022/A01, KSC-BC-2023-11/F00022/A02 and

KSC-BC-2023-11/F00022/A03, which it asserts should remain confidential and be

marked *ex parte* to Mr Shala insofar as they contain private information relating to

Mr Shala and are largely administrative in nature.<sup>13</sup>

8. With regard to the reclassification of filings presently classified as strictly

confidential and ex parte in the case records of Case 10 and Case 11, the SPO

submits that it will file confidential redacted versions of the following filings:

- 9. The SPO also submits that, following the filing of confidential redacted versions of the above filings in the case record of Case 11, no other prosecution filings will remain in said record for which a confidential redacted version has not already been produced. 15 With respect to all remaining prosecution filings in the case record of Case 10 record, the SPO asserts that the strictly confidential and ex parte classification remains necessary in order to protect the integrity, security and confidentiality of SPO investigations, and that their reclassification, even in redacted form, would be conflict with the purpose for their classification in the first instance.16
- In particular, the SPO reiterates that the current classification remains necessary for the following filings in the case record of Case 10, in order to protect the integrity, security and confidentiality of SPO investigations, as well as [REDACTED].<sup>17</sup> The SPO maintains that [REDACTED].<sup>18</sup>

III. DISCUSSION

11. Having considered the SPO's submissions and considering that the Defence

does not raise any objections, the Pre-Trial Judge finds that all confidential (and

not marked as ex parte) filings and their respective annexes in the records of

Case 10 and Case 11 shall be made available to all three accused, with the

exception of the following annexes in Case 11, which shall retain their confidential

classification and be marked as ex parte, only available to the Defence for Mr Shala

and the SPO:

KSC-BC-2023-11, F00022/A01 (currently classified as confidential);

• KSC-BC-2023-11, F00022/A02 (currently classified as confidential); and

• KSC-BC-2023-11, F00022/A03 (currently classified as confidential).

12. The Pre-Trial Judge further orders the SPO to file confidential and public

redacted versions of the following filings, including their corresponding annexes,

in their respective case records, i.e. Case 10 and Case 11, to be made available to

all three accused, or to provide reasons why a confidential and/or public redacted

version cannot be provided at this time:

• KSC-BC-2023-10/F00010 (currently classified as strictly confidential and

ex parte), with KSC-BC-2023-10/F00010/A01 (currently classified as

strictly confidential);

• KSC-BC-2023-10/F00136 (currently classified as strictly confidential and

ex parte);

Furthermore, the Pre-Trial Judge does not find it necessary for filings previously transferred from the KSC-BC-2018-01 file record into the Case 10 record to also be transferred into the Case 11 record, 19 as Mr Shala will have access to those filings in the record of Case 10. The Pre-Trial Judge further clarifies that: (i) any forthcoming confidential and/or public redacted versions of either: (a) Case 10 filings<sup>20</sup> or (b) filings that will be transferred from the KSC-BC-2018-01 file into the Case 10 record,<sup>21</sup> shall be filed in the record of Case 10; and (ii) any forthcoming confidential and/or public redacted versions of Case 11 filings shall be filed in the Case 11 record.<sup>22</sup>

With respect to the remainder of filings classified as strictly confidential and ex parte in Case 10, i.e. SPO filings and related decisions/orders or any other related filing, the Pre-Trial Judge finds it appropriate that they retain their current classification.23

**ORDERS** the Registrar to make available to all three accused all C.

confidential filings and related annexes (not marked as ex parte) in the

Case 10 and Case 11 records, in accordance with paragraph 11 of the

present decision; and

d. **ORDERS** the Registrar to cross-file the present decision in the KSC-BC-

2018-01 and KSC-BC-2023-11 case records.
