1. Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W02082, W04870, W04325, W00498 and W04576. On 28 March 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimony of W00498, W04325, W02082 and W04870. On the same day, Victims' Counsel sent his response agreeing with the SPO's proposed redactions, and proposing additional redactions to the testimony of W02082 and W04870. The SELIMI Defence sent proposals to lift redactions to excerpts of W04325's testimony. The other Defence teams did not send a response.

2. The SPO has consolidated all proposed redactions and related justifications in Annexes 1-3.<sup>2</sup>

3. Annexes 1-3 are confidential in accordance with Rule 82(4) and to give effect to existing protective measures.
