Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W01140. On 28 March 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimony of W01140. On 2 April 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions, and proposing additional redactions as well as to lift redactions to excerpts of W01140's testimony. The Defence teams did not send a response.
2. The SPO has consolidated all proposed redactions and related justifications in Annex 1.<sup>2</sup>
3. Annex 1 is confidential in accordance with Rule 82(4) and to give effect to existing protective measures.
