#### I. INTRODUCTION

1. Pursuant to the Decision,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') hereby submits its detailed notice of the disclosure process related to KSC-BC-2023-10 ('Case 10').

#### II. SUBMISSIONS

- 2. During the pre-trial phase of the case, the disclosure of evidence between the Parties and communication to the Pre-Trial Judge was governed in Case 10 by the Case 10 Framework Decision,<sup>2</sup> and in KSC-BC-2023-11 ('Case 11') by the Case 11 Framework Decision<sup>3</sup> (collectively the 'Framework Decisions'). In the Framework Decisions, the Pre-Trial Judge set out the principles governing disclosure of evidence between the Parties, set out the procedure for disclosure of evidence, established a calendar for disclosure of evidence by the SPO, and adopted the redaction regime applicable to Case 10 and Case 11.<sup>4</sup> The SPO's pre-trial disclosure obligations were set to be completed by 16 February 2024.<sup>5</sup> By way of the Decision, this was extended to 19 April 2024,<sup>6</sup> subject to any items requiring judicial authorisation,<sup>7</sup> in respect to a small volume of material arising from (then) pending investigative steps.
- 3. In addition to a calendar for disclosure, the Pre-Trial Judge regulated restrictions to disclosure.<sup>8</sup> In this respect, the Pre-Trial Judge established general

principles underpinning restrictions to disclosure,<sup>9</sup> the legal test for withholding certain information from the receiving party,<sup>10</sup> and a regime governing the application of standard and non-standard redactions to disclosable materials.<sup>11</sup> On this basis, the SPO submitted a total of three (3) requests for protective measures,<sup>12</sup> which were ruled on with three (3) decisions by the Pre-Trial Judge.<sup>13</sup> The Pre-Trial Judge granted protective measures for two witnesses, which are listed in the SPO List of Witnesses filed pursuant to Rule 95(4)(b) of the Rules.<sup>14</sup> In addition, the SPO submitted a materiality challenge to an item disclosable under Rule 102(3),<sup>15</sup> which was granted in part,<sup>16</sup> and in accordance with which the SPO provided the Defence with a summary of the item in question on 18 April 2024.

4. On 8 February 2024, the Pre-Trial Judge granted joinder of the confirmed indictments in Case 10 and Case 11.<sup>17</sup> Prior to the joinder, fifteen (15) disclosure packages were disclosed in Case 10, and seven (7) packages were disclosed in Case 11.

Since the joinder, another fourteen (14) packages were disclosed. On 19 April 2024, the SPO disclosed to Haxhi Shala the latest versions of all items previously disclosed to the other two Accused in Case 10 prior to the joinder of Case 10 and Case 11. In accordance with the calendar established by the Pre-Trial Judge, and as further set forth below, the SPO released a total of 34 disclosure packages 19 to the Defence, 20 and communicated the same to the Pre-Trial Judge, through Legal Workflow.

5. The SPO filed a supplemental Rule 102(3) notice on 19 April 2024, and will continue to review any newly received materials for relevance and/or exculpatory content, as applicable.<sup>21</sup>
