

Pursuant to the Order on the Conduct of Proceedings<sup>1</sup> and Rule 102(3) of the Rules,<sup>2</sup> the Specialist Prosecutor's Office ('SPO') hereby submits a supplemental Rule 102(3) notice ('May 2024 Notice').<sup>3</sup> The May 2024 Notice includes items falling under Rule 102(3) which have been recently identified, obtained, or cleared.<sup>4</sup> The SPO will continue to discharge its obligations under Rule 102(3), including as additional items falling within the scope of the Rule are obtained or cleared.
