1. Pursuant to Rule 26 of the Rules,<sup>1</sup> the Registrar hereby informs the Pre-Trial Judge of the conditional assignment of Mr Toby Cadman ('Mr Cadman') as Counsel to Mr Haxhi Shala ('Mr Shala').<sup>2</sup>
2. Between 10 April and 2 May 2024, Mr Cadman submitted to the Defence Office, on behalf of his client, a request for legal aid under the Specialist Chambers' Legal Aid Regulations,<sup>3</sup> and a corresponding request for the assignment of Counsel.
3. Mr Cadman is admitted to the List of Specialist Counsel in accordance with Rules 25(1) and 26(1) of the Rules and the Directive on Counsel.<sup>4</sup>
4. On 13 May 2024, the Registrar conditionally assigned Mr Cadman as Counsel to Mr Shala, in accordance with Sections 12 and 14(3) of the Directive on Counsel and Regulation 11 of the Legal Aid Regulations.
5. Consequently, that same day, the Registrar terminated Mr Cadman's appointment as Counsel, and Mr John Cubbon's and Ms Almudena Bernabeu Garcia's appointment as Co-Counsel, for Mr Shala.<sup>5</sup>
6. Pursuant to Rule 82(3) of the Rules, Annexes 1 and 2 are submitted as confidential, as they contain the personal details of Counsel and former Defence Team Members.
