1. The Defence for Mr. Haxhi Shala requests that Haxhi Shala Submissions for Review of Detention<sup>1</sup> (“F00210”), Reply to the Prosecution Submission Pertaining to Periodic Detention Review of Haxhi Shala<sup>2</sup> (“F00232”) and Urgent Supplement to Reply to the Prosecution Submission Pertaining to Periodic Detention Review of Haxhi Shala<sup>3</sup> (“F00237”) be reclassified.
2. In the Second Decision on Review of Detention of Haxhi Shala<sup>4</sup> the Pre-Trial Judge ordered the Haxhi Shala Defence to file public redacted versions of F00210, F00232 and F00237 or to indicate whether these filings may be reclassified as public.<sup>5</sup>
3. The Haxhi Shala Defence submits that F00210, F00232 and F00237 do not contain material that should now be confidential.
4. Therefore, having due regard for the need for proceedings to be public in nature, for confidential filings to be properly justified and for any redactions to be strictly necessary, the Haxhi Shala Defence requests that the Pre-Trial
