1. Pursuant to Rule 26 of the Rules,¹ the Registrar hereby informs the Pre-Trial Judge of the conditional approval of Mr John Cubbon ('Mr Cubbon') as Co- Counsel to Mr Haxhi Shala ('Mr Shala').²
2. Until 13 May 2024, Mr Cubbon was appointed as Co-Counsel to Mr Shala; on that day, his appointment was terminated as a result of the termination of Mr Toby Cadman's ('Mr Cadman') appointment as Counsel for Mr Shala, which followed Mr Cadman's conditional assignment as Counsel for Mr Shala.³
3. On 13 May 2024, Mr Cadman informed the Head of the Defence Office that he would like to be assisted by Mr Cubbon as Co-Counsel. By 31 May 2024, Mr Cadman had provided all relevant documentation pursuant to Section 18 of the Directive on Counsel.⁴
4. Mr Cubbon is admitted to the List of Specialist Counsel in accordance with Rules 25(1) and 26(1) of the Rules and the Directive on Counsel.
5. On 4 June 2024, the Registrar conditionally approved Mr Cubbon as Co-Counsel for Mr Shala, in accordance with Section 18 of the Directive on Counsel and Regulations 28 and 29 of the Legal Aid Regulations.⁵
6. Pursuant to Rule 82(3) of the Rules, Annexes 1 and 2 are submitted as confidential, as they contain the personal details of Counsel, Co-Counsel and other (former) Defence Team Members.


