1. As ordered, the Specialist Prosecutor's Office ('SPO') hereby makes submissions concerning the redactions to ERNs applied in the 8 January 2024 Decision,¹ 12 February 2024 Decision,² and 22 May 2024 Decision.³

2. In the circumstances of W02144 and W04741,⁴ redactions to all ERNs of the Proposed Evidence in the 8 January 2024 Decision are no longer necessary,⁵ as the witnesses have testified without in-court protective measures and, as appropriate, their evidence has been admitted.

3. Consistent with the SPO's previous submissions,⁶ to give effect to the witness's in-court protective measures, the [REDACTED] ERNs of W04305's Proposed Evidence in the 22 May 2024 Decision must remain redacted,⁷ including after his testimony.

Documents with [REDACTED], and therefore, in order to not reveal his identity as a witness, the ERNs need to remain redacted.

4. Finally, the ERNs of certain associated exhibits of witnesses W04446 and W04410 were redacted in the 12 February 2024 Decision⁸ and the 22 May 2024 Decision,⁹ respectively. While W04446 has protective measures, the redactions to the ERN of a related associated exhibit in the 12 February 2024 Decision are not necessary, as the ERN itself is not identifying. Likewise, the redactions to ERNs of associated exhibits for W04410 in the 22 May 2024 Decision are not necessary, noting that W04410 has now testified without protective measures.
