

1. Pursuant to Rule 26(1) of the Rules,<sup>1</sup> the Registrar hereby informs the Trial Panel of the conditional approval of Ms Shyamala Alagendra Khan ('Ms Alagendra Khan') as Co-Counsel for Mr Jakup Krasniqi ('Mr Krasniqi').
