- On 26 June 2024, Trial Panel II approved the request of witness W04846 to be provided with pen and plain empty sheet of paper during his testimony, subject *inter alia* that any notations he made remain in the courtroom after the witness has concluded his testimony and that once the witness has finished testimony, the Court Management Unit ("CMU") destroy the notes.¹
- As instructed, CMU provided six (6) sheets of blank A4 printing paper and a blue ink pen for the witness to use during his testimony.

4. After the hearing adjourned at 15:31hrs, CMU retrieved the provided pen and paper from the Witness desk. CMU notes that the witness wrote on one (1) of the provided sheets of paper. The said sheet of paper was destroyed by CMU on 27 June 2024.
5. CMU confirms that there are no other copies of Witness W04846's notes made in the courtroom during his testimony on 26 June 2024.
