- 1. As indicated in Filing F00090,<sup>1</sup> and pursuant to Order F00083,<sup>2</sup> the Specialist Prosecutor's Office ('SPO') notifies the Pre-Trial Judge that it has filed public redacted versions of filings F00004, F00023, F00036, F00040, F00042, and F00044.
- 2. Further, pursuant to Rule 82(5) of the Rules,<sup>3</sup> the SPO requests the Pre-Trial Judge to direct the Registry to reclassify filing F00024/CONF/RED as public. No additional redactions *vis-à-vis* the public are required.
- 3. Having reviewed filings F00013, F00047, F00047/A01, F00047/A02, F00049, F00049/A01, F00049/A02, F00049/A03, F00049/A04, F00052, F00052/A01, F00057, F00057/A01, F00059, F00060, and F00061, the SPO informs the Pre-Trial Judge that the filings' current classification as 'confidential' remains necessary<sup>4</sup> for the time being because of the nature of the information in those filings. For example, they contain personal identifiable information of the Accused and innocent third parties as well as information which, if divulged, could prejudice ongoing SPO investigations.
