1. Pursuant to the Search and Seizure Decision,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') hereby requests the Single Judge's authorisation for the SPO's further retention of the seized mobile phone of Haxhi SHALA (the 'SHALA Phone').
2. As previously detailed to the Single Judge, the SPO is actively investigating efforts undertaken by SHALA, JANUZI, BAHTJIARI (collectively, the 'Accused'), and others aimed at obstructing the testimony of a protected witness [REDACTED].<sup>2</sup> Based on evidence uncovered during its investigation, the SPO submitted Indictments for confirmation against SHALA, JANUZI and BAHTIJARI.<sup>3</sup> On 2 October 2023, the Pre-Trial Judge in KSC-BC-2023-10 ('Case 10') confirmed the Indictment against JANUZI and BAHTIJARI,<sup>4</sup> and on 4 December 2023, the Pre-Trial Judge in KSC-BC-2023-11 ('Case 11') confirmed the Indictment against SHALA.<sup>5</sup> On 11 December 2023, the SPO arrested SHALA<sup>6</sup> and subsequently seized the SHALA Phone.<sup>7</sup> [REDACTED].

The SHALA Phone is listed as item #1 in the list of seized evidence and was placed in evidence bag #E215622. The SPO's review and analysis of the SHALA Phone remains ongoing.

3. Relevant data has already been extracted from the SHALA Phone, which the SPO will retain consistent with the Search and Seizure Decision and the Rules.<sup>8</sup> However, the SPO's retention of the physical phone itself is also necessary. Specifically, it is necessary for the SPO to retain the SHALA Phone through the conclusion of the proceedings in Case 10 and Case 11.

4. Such retention is necessary to, *inter alia*, (i) preserve the ability to conduct further forensic investigation of the SHALA Phone as necessary, (ii) ensure the proper preservation of the original evidence for potential use in Case 10 and Case 11, and (iii) ensure the rights of the Accused to inspect and examine the physical item in support of the Accused's rights to a fair trial.

5. Accordingly, the SPO requests the Single Judge to authorise the SPO to retain the SHALA Phone until at least the conclusion of proceedings in Case 10 and Case 11.

6. This filing is submitted as strictly confidential and *ex parte* in accordance with Rule 82(4).
