1. Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W02540, W03881, W04710, W04230 and W04305. On 20 June 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions for W02540, W03881, W04230 and W04305, and proposing additional redactions for W04710. On 24 June 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions for W02540, W03881, W04230 and W04305. The Defence teams did not send a response.

2. The SPO has consolidated all proposed redactions and related justifications in Annex 1.<sup>2</sup>
