Pursuant to the Order,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') hereby tenders the audio-video recordings of witness statements previously admitted pursuant to Rule 143(2)(c) of the Rules.<sup>2</sup> These audio-video recordings are listed in Annex 1,<sup>3</sup> with the corresponding witness codes, ERNs and exhibit numbers of admitted statements, disclosure packages, and admission decisions.<sup>4</sup> For W04576 and W04746, only discrete portions of their prior statements were admitted. Due to technical reasons, the SPO has disclosed the full audio-video recordings for each interview part—however, it only seeks admission of the segments at the timestamps which correspond to the admitted portions of the transcripts, as specified in the Annex. To the extent the Panel considers it appropriate to admit the relevant part of the video in full, for the limited purpose of assessing the witness's demeanour when giving the prior statement, the SPO does not object.
