

1. Pursuant to the Oral Order¹ and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcript for all private session testimony of W03170, W04410, and W04824. On 3 July 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimonies of W03170 and W04824. On 8 July 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions for W04410 and W04824, and proposing additional redactions and to lift certain SPO redactions relating to W03170's testimony. On 9 July 2024, the THAÇI Defence proposed to lift certain SPO redactions to W03170's testimony. The other Defence teams did not send a response.
2. The SPO has consolidated all proposed redactions and related justifications in Annex 1.²
3. Annex 1 is confidential in accordance with Rule 82(4) and to give effect to existing protective measures.
