I. BACKGROUND

- 1. On 27 February 2024, the Pre-Trial Judge instructed the Registrar to file weekly updates, starting on 1 March 2024, on the situation concerning the funding of the Defence teams for Mr Sabit Januzi ('Mr Januzi'), Mr Ismet Bahtijari ('Mr Bahtijari') and Mr Haxhi Shala ('Mr Shala') by the Ministry of Justice of Kosovo pursuant to Law No. 05/L-054.¹ The Registrar hereby provides her twenty-third update.
- 2. On 27 March 2024, the Pre-Trial Judge instructed the Defence teams, should they (still) intend to request legal aid from the Specialist Chambers, to submit the required forms and any necessary supporting documentation to the Registry, and inform the Pre-Trial Judge thereof by Friday, 12 April 2024.² Should the Defence teams encounter any obstacle that impedes them from filling out the required forms or submitting any supporting documentation within the prescribed time limit, the Pre-Trial Judge instructed them to file written submissions on the matter without delay.³
- 3. Following requests for legal aid by Mr Shala and Mr Bahtijari, on 17 May 2024, the Registrar informed the Pre-Trial Judge that Mr Toby Cadman had been conditionally assigned as Counsel to Mr Shala and that Dr Felicity Gerry had been conditionally assigned as Counsel to Mr Bahtijari.⁴ As a result, no further updates are anticipated at this time concerning the funding of those two Defence Teams. The Defence Office is in regular contact with Counsel to ensure that they have all of the necessary information and assistance that may be required under the Legal Aid Regulations.⁵
- 4. With respect to Mr Januzi, an update on the status of Defence funding is provided below.
