- 1. On 3 May 2024, the Single Judge ordered Mr Isni Kilaj's ('Mr Kilaj') release from detention in Kosovo, subject to strict conditions ('Decision'). Among others, the Single Judge ordered Mr Kilaj to provide a financial security to the Registrar in the form of a monetary transfer in the amount of EUR 30,000, to be paid in full within two (2) weeks of notification of the Decision, [REDACTED], as a pre-condition for his release. The Single Judge also ordered the Registrar to put on record when Mr Kilaj's financial security has been received.
- 2. The Specialist Prosecutor's Office appealed the Decision on 6 May 2024, and requested suspensive effect.<sup>4</sup>
- 3. On 6 May 2024, the Registrar conveyed a letter to Mr Kilaj<sup>5</sup> and his Counsel, providing, among others, the necessary [REDACTED] information for the payment of the financial security.
- 4. Pursuant to the Decision, the Registrar hereby notifies the Court of Appeals Panel that the amount of EUR 30,000 was received [REDACTED] on 7 May 2024.
- 5. This filing is submitted as confidential pursuant to Rule 82(4) of the Rules.<sup>6</sup>
