**THE PRESIDENT** of the Specialist Chambers ("President"), acting pursuant to Articles 33(1)(b) and 40(1) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, Rules 98(3) and 115 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers ("Rules") and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns Trial Panel I following the "Notification Pursuant to Rule 98(3) of the Rules of Procedure and Evidence" by the Pre-Trial Judge, that a complete case file of the present case will be ready for transmission to a Trial Panel on 4 September 2024 ("Notification").<sup>1</sup>

#### I. PROCEDURAL BACKGROUND

1. On 2 October 2023, the Pre-Trial Judge confirmed the indictment against Mr Sabit Januzi and Mr Ismet Bahtijari, a redacted version of which was made public on 12 October 2023.<sup>2</sup>

2. On 5 October 2023, Mr Januzi and Mr Bahtijari were arrested in Kosovo pursuant to an arrest warrant issued by the Pre-Trial Judge on 2 October 2023<sup>3</sup> and were transferred to the Detention Facilities of the Specialist Chambers in The Hague, the Netherlands, on 6 October 2023.<sup>4</sup>

3. On 4 December 2023, the Pre-Trial Judge confirmed the indictment against

Mr Haxhi Shala, a redacted version of which was made public on 30 January 2024.<sup>5</sup>

4. On 11 December 2023, Mr Shala was arrested in Kosovo pursuant to an arrest warrant issued by the Pre-Trial Judge on 4 December 2023<sup>6</sup> and was transferred to the Detention Facilities of the Specialist Chambers in The Hague, the Netherlands, on 12 December 2023.<sup>7</sup>

5. On 8 February 2024, the Pre-Trial Judge granted a request by the Specialist Prosecutor's Office to join the case of Mr Januzi and Bahtijari with that of Mr Shala.<sup>8</sup>

6. On 3 September 2024, the Pre-Trial Judge filed the Notification.<sup>9</sup>

II. ASSIGNMENT

7. Having considered the criteria set forth in Rule 4(2) of the Rules on Assignment, including relevant experience and expertise as well as availability at this time,

### THE PRESIDENT HEREBY ASSIGNS TRIAL PANEL I, COMPOSED OF:
