THE PRESIDENT of the Specialist Chambers (“President”), noting Articles 33(1)(d) and 33(6) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor’s Office (“Law”), Rule 79 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on Assignment of Specialist Chambers Judges from the Roster of International Judges (“Rules on Assignment”), herewith assigns a Supreme Court Panel to decide on “Haxhi Shala’s Refiled Request for Reconsideration of the Supreme Court Chamber’s Decision on Haxhi Shala’s Request for Protection of Legality” (“Request”).¹

I. PROCEDURAL BACKGROUND

1. On 9 September 2024, the Supreme Court Panel issued the “Decision on Haxhi Shala’s Request for Protection of Legality”, wherein it rejected the “Request for Protection of Legality against Haxhi Shala’s Appeal Against Decision on Review of Detention”.²
2. On 18 September 2024, Mr Shala filed the Request.

II. ASSIGNMENT

3. Having considered Article 33(6) of the Law and the criteria set forth in Rule 4(2) of the Rules on Assignment, as well as the nature of the Request, which makes it necessary to assign the same composition of Judges,


