## Joint request for extension of time

- 1. Pursuant to Rule 6(4) of the Rules,¹ Victims' Counsel and the Specialist Prosecutor's Office ('SPO') jointly request that the Specialist Chamber of the Constitutional Court grant an extension of the time limit to 11 November 2024 to make referral(s) under Article 49 of the Law² following the Supreme Court Decision.³ There is good cause for the requested extension, in particular, to synchronise the briefing schedule for referrals pertaining to the Supreme Court Decision and the subsequent, related Sentence Decision.⁴
- 2. The Supreme Court Decision was final in respect of certain findings concerning the criminal law applicable to sentencing.<sup>5</sup> However, the Supreme Court Panel also returned the Appeal Judgment<sup>6</sup> to the Appeals Panel for a new determination of the convicted person's sentence.<sup>7</sup> On 10 September 2024, the Appeals Panel issued the Sentence Decision applying the principles from the Supreme Court Decision. Accordingly, while the deadline for any referral relating to the Supreme Court Decision is 1 October 2024, any referral relating to the Sentence Decision is due by 11 November 2024.<sup>8</sup>
- 3. In the circumstances and considering that the Supreme Court Decision and Sentence Decision are related, a synchronised briefing schedule for both will facilitate fair and expeditious proceedings, and assist effective case management. In this respect, the requested extension would: (i) provide Victims' Counsel and the SPO

adequate opportunity to fully consider available and appropriate remedies, including any Article 49 referral(s);<sup>9</sup> (ii) ensure that Victims' Counsel and the SPO have the opportunity to, as appropriate, analyse and address these rulings – one of which was notified ten days ago – holistically; and (iii) avoid potentially incomplete and fragmented submissions concerning the rulings and their impact.

4. No prejudice would arise from granting the requested extension, noting that the two decisions in question relate to the same proceedings. Hearing any related referrals on a synchronised schedule is likely to ultimately result in greater efficiency and better facilitate their consideration.
