Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcript, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W01129, W04366, W04600 and W04737. On 21 October 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimony of W04366, W04600 and W04737. On 21 October 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions. The Defence teams did not send a response.
