I. INTRODUCTION

- 1. This is the current list of witnesses the defence for Mr Bahtijari intends to call at trial pursuant to Rule 119 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers ('Rules').
- 2. This document is also a notice of a current intention to call expert evidence pursuant to Rule 149 of the Rules.

II. PROCEDURAL BACKGROUND

- 3. The defence filed a draft witness list as part of their submissions for the trial preparation hearings.¹ This list replaces the list contained in that submission.²
- 4. In an oral order made by the Trial Chamber during the trial preparation hearing on 8 October 2024, the defence was ordered to provide their witness list by 4 November 2024.³

III. WITNESS LIST

- 5. In accordance with Rule 119(2), the defence for Mr Bahtijari submits that it estimates the total time required for the presentation of the defence case will be 5 days. Further, as outlined in the below list of witnesses, the defence expects a total of 18 witnesses to testify for Mr Bahtijari. Each of the witness's testimony will be relevant to all charges and paragraphs of the indictment that relate to Mr Bahtijari. Mr Bahtijari is not expected to appear as a witness.
- 6. The following list sets out the witnesses for the defence and provides additional information on each witness as requested by the Panel and in accordance with Rule 119(2)(a)(iii)-(vii):
