1. Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W01163.

2. On 31 October 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions. On 5 November 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions and proposing two additional redactions. The Defence teams did not send a response.

3. The SPO has consolidated all proposed redactions and related justifications in Annex 1.<sup>2</sup>
