## I. PROCEDURAL BACKGROUND

- 1. On 1 May 2024, the Defence for Mr Ismet Bahtijari ('Mr Bahtijari', 'the Accused' or 'the Defence') requested the Pre-Trial Judge to order four expert medical assessments of Mr Bahtijari in relation to (i) the Accused's fitness to stand trial, and (ii) certain defences envisaged to be presented at trial ('Request').<sup>1</sup>
- 2. Pursuant to [REDACTED],<sup>2</sup> the Registrar filed submissions related to the Request.<sup>3</sup> Among other things, the Registrar recalled that the Defence may engage any experts it deems appropriate, and decide whether and how to make use of expert witness evidence in the proceedings, including whether to put reports so obtained on the record. The Registrar further noted that under the Legal Aid Regulations, Counsel is provided with funding for contracting experts (i.e., external consultants).<sup>4</sup>

- 6. Pursuant to [REDACTED], the Defence updated its Request on 25 September 2024.<sup>11</sup> Specifically, the Defence withdrew its request for a medical assessment of Mr Bahtijari's fitness to stand trial; however, the Defence reiterated its request for

judicial intervention to obtain medical evidence that goes to Mr Bahtijari's defences, as outlined in the Request and the [REDACTED].<sup>12</sup>

## II. SUBMISSIONS

- 7. In view of the Defence's withdrawal of the request for an assessment of fitness of the Accused to stand trial, the Registrar makes no observations on the matter. However, the Registrar [REDACTED] (a) [REDACTED], (b) [REDACTED], and (c) the request for [REDACTED] contact information.
- 8. Firstly, in relation to legal aid, the Registrar reiterates that Mr Bahtijari benefits from legal aid from the Specialist Chambers as of 10 May 2024,<sup>13</sup> and that under the Legal Aid Regulations, EUR 10,250 is allotted to Assigned Counsel for contracting external investigators/consultants for all stages of the proceedings.<sup>14</sup> Counsel may engage any expert(s) it deems appropriate and remunerate them from this allotted amount. This enables the Defence to elect to carry out independently in the preparation of its defence any examinations it deems necessary and to control and decide whether it wishes to [REDACTED].<sup>15</sup>
