1. On 17 December 2024, the Pre-Trial Judge, *inter alia*, directed the Registrar to do the following by Friday, 10 January 2025 ('Directions'):

  - c. submit confidential redacted versions and/or public redacted versions, of the following core filings: (i) F00064; (ii) F00065; (iii) F00066; (iv) F00067; and (v) F00068.<sup>1</sup>
2. On 10 January 2024, the Registry submitted redacted filings pursuant to Directions (a)(i)-(iii) and (c)(ii)-(iv), as set out above. Regrettably, due to an oversight, redacted filings pursuant to Directions (b), (c)(i) and (c)(v) were submitted after the deadline, namely on Saturday, 11 January 2025. This was done as soon as practicable after the above-mentioned oversight came to light.
3. The Registry files these submissions as confidential, pursuant to Rule 82(4) of the Rules,<sup>2</sup> in line with the classification of the Pre-Trial Judge's Directions. The Registry has no objection to these submissions being reclassified as public.
