Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcripts, the Specialist Prosecutor's Office ('SPO') sent inter partes the proposed lesser redacted transcripts for all private session testimony of W00344 and W04679. On 17 December 2024, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimony of W00344 and W04679. On 18 December 2024, Victims' Counsel sent his response agreeing with the SPO's proposed redactions for W00344 and W04679, and proposing additional redactions as well as lesser redactions to the testimony of W00344. The Defence teams did not send a response.

- 2. The SPO has consolidated all proposed redactions and related justifications in Annex 1.2
