## I. INTRODUCTION

1. Pursuant to Rule 82(3) of the *Rules of Procedure and Evidence* and the Trial Panel's oral order on 4 February 2025, the Defence for Mr Ismet Bahtijari ('the Defence') hereby submits its reasons for retaining the confidential classification of F00637 and F00650 in relation to the request for Mr Bahtijari's release on humanitarian grounds.

#### II. PROCEDURAL HISTORY

- 2. On 6 January 2025, the SPO requested for continued detention of Mr Bahtijari.<sup>1</sup>
- 3. On 10 January 2025, the Defence filed its submissions on detention which included a request for Mr Bahtijari's release on humanitarian grounds (F00637).<sup>2</sup>

  A public redacted version was filed on 3 February 2025.<sup>3</sup>
- 4. On 15 January 2025, the Panel ordered responses by the Registry and the SPO to the Defence request,<sup>4</sup> who did so on 16, 17 and 21 January respectively.<sup>5</sup>
- 5. On 17 January 2025, the Defence submitted an addendum report from Professor Henry Kennedy.<sup>6</sup> A public redacted version of the cover filing was filed on 5 February 2025.<sup>7</sup>

- 6. On 22 January 2025, the Defence replied to the Registry and SPO responses on review of detention and humanitarian release (F00650).8
- 7. On 23 January 2025, the Registry made further submissions in response to F00650.9
- 8. On 4 February 2025, the Trial Panel ordered the Defence to indicate whether it disagrees with the reclassification of F00637 and F00650 to public and, if so, specify the reasons pursuant to Rule 82(3) and indicate whether and when the classification may be changed. If the classification is to retained, the Defence is ordered to file public redacted versions by 11 February 2025.<sup>10</sup>

#### III. SUBMISSIONS

- 9. The two filings in question contain discussion about Mr Bahtijari's personal and medical circumstances. Their confidential classification should be retained to protect Mr Bahtijari's privacy.
- 10. Sensitive personal data are protected under Kosovo's *Law on Protection of Personal Data*. <sup>11</sup> The confidentiality of such data does not expire. <sup>12</sup> Therefore, the current classification filings cannot be changed in any foreseeable circumstances.
- 11. The Defence has already submitted the public redacted version of F00637 with the sensitive information removed. It undertakes to the same for F00650 by 11 February 2025. The limited extent of redaction would satisfy the interest of public access to the judicial proceedings.
