1. On 14 April 2023, in response to a request ('the Request')<sup>1</sup> by the Specialist Prosecutor's Office ('SPO'), the Single Judge issued the "Decision on Urgent Prosecution Supplemental Requests in Relation to [REDACTED] F00321" ('F00330 Decision').<sup>2</sup> In the F00330 Decision, among other things, the Single Judge ordered the Registrar to provide the SPO with access to certain detention records, including telephone logs, of the Specialist Chambers ('SC') Detention Facilities in relation to Mr Thaçi and Mr Veseli, starting from 5 August 2022 up to the date of the Decision (14 April 2023), and on a rolling and daily basis through 31 May 2023 ('Telephone Logs').<sup>3</sup>
2. The Registrar hereby informs the Single Judge of one aspect related to the execution of the F00330 Decision, related to the Telephone Logs.
3. In line with the F00330 Decision, the Registrar instructed the Detention Management Unit of the Registry to compile the relevant records and make them available to the SPO as soon as practicable, and on a rolling basis.
4. In line with the Practice Direction on Visits and Communications, telephone logs and digital recordings of Detainees' conversations are retained for a period not exceeding eight (8) months from their creation.<sup>4</sup>
5. All telephone data from the Detention Facilities is contained within the [REDACTED]. [REDACTED].
6. The Telephone Logs were retrieved [REDACTED] on 17 April 2023 (the first working day after the F00330 Decision was issued). Telephone Logs older than 8 months had already been [REDACTED] deleted. [REDACTED].

7. The first recorded call in the system dates from 21 August 2022. Therefore, Telephone Logs for telephone calls from 21 August 2022 through 31 May 2023, as covered by the F003330 Decision, have been provided to the SPO.

8. Pursuant to Rule 82(3)-(4) of the Rules,<sup>5</sup> this submission is filed as strictly confidential and *ex parte*.
