- 1. Pursuant to Order F00814¹ and Rule 82(5) of the Rules,² the Specialist Prosecutor's Office ('SPO') hereby notifies the Single Judge that it has submitted (lesser) confidential and public redacted versions, to the extent possible, of the SPO filings and annexes listed in F00799/A01.³
- 2. The redactions applied to these filings and annexes⁴ are necessary to protect: (i) the integrity, security, and confidentiality of SPO ongoing investigations and investigative methodologies; (ii) [REDACTED]; (iii) [REDACTED];⁵ and (iv) personal identifying information or other private information relating to the KSC-BC-2023-12 ('Case 12') Accused, uncharged co-perpetrators, or innocent third parties.
- 3. In addition, the SPO today requested the Single Judge to order the reclassification of certain filings and annexes as confidential and/or public.⁶
- 4. For the remainder of the filings and annexes, the current classification vis-à-vis the Case 12 Accused and the public remains necessary, because reclassification, even in redacted form, is not possible at this time.
- 5. Annex 1 provides an overview of all SPO filings and annexes and the decisions taken pursuant to Order F00814 vis-à-vis the Case 12 Accused and the public.⁷
