On 14 February 2025, the Defence for Mr Hashim Thaçi (the "Defence") filed

INTRODUCTION AND PROCEDURAL BACKGROUND

the Urgent Thaçi Defence Request for Temporary Release on Compassionate

2. On 18 February 2025, at the request of the Trial Panel,² the Defence

supplemented the Request with additional medical reports related to the

hospitalisation of Mr Haxhi Thaçi between [REDACTED] February 2025.3

3. On 19 February 2025, the Trial Panel issued the "Decision on Thaçi Defence

Fourth Urgent Request for Temporary Release on Compassionate Grounds", 4 rejecting

the request on the basis that "on balance and in the present circumstances, the medical

condition of Mr Haxhi Thaçi does not amount to compelling humanitarian grounds

justifying Mr Thaçi's temporary release for a custodial visit." The Panel also invited

the Thaçi Defence "to notify the Panel, without delay, of any information suggesting

that the requisite threshold for temporary release has been met."6

4. On [REDACTED] March 2025, the Thaçi Defence received a new medical report

containing more recent information concerning the condition of Mr Haxhi Thaçi, who

is currently hospitalised at [REDACTED].7 On this basis, and in compliance with the

Trial Panel's instructions, the Defence reiterates its request for temporary release on

compassionate grounds.

II. **SUBMISSIONS**

5. Mr Haxhi Thaçi's health had already deteriorated since Trial Panel issued the

Decision on the Urgent Thaçi Defence Request for Temporary Release on

Compassionate Grounds on 31 January 2025,8 as detailed in the Medical Reports

submitted with the Defence Supplement to Request.9

6. As indicated in the Medical Reports, Mr Haxhi Thaçi was hospitalised on

[REDACTED] February 2025¹⁰ and discharged on [REDACTED] February 2025 with

[REDACTED]".11

7. Mr Haxhi Thaçi was subsequently hospitalised several more times over the

past few weeks in different clinics because of his deteriorating medical condition.¹² As

noted in the Report of [REDACTED] March 2025, he is diagnosed with [REDACTED].

8. Two days prior to the issuing of this report, Mr Haxhi Thaçi had

9. All of these elements lead the doctor, author of the [REDACTED] March 2025

report, to conclude that his condition could deteriorate further and lead to death at

any moment.14

10. This latest medical report and clear conclusion unequivocally confirm the

deteriorated state of health of Mr Haxhi Thaçi, amounting to compelling

humanitarian grounds justifying Mr Hashim Thaçi's temporary release for a custodial

visit allowing him to visit and comfort his father and close relatives.

III. CLASSIFICATION

11. This filing is classified as confidential and *ex parte* as it refers to sensitive

medical information concerning Mr Thaçi's father. A public redacted version will be

filed in due course.

CONCLUSION IV.

12. For the above reasons, the Defence maintains its request that the Trial Panel

order the immediate temporary release of Mr Thaçi on compassionate grounds, for a

period of one (1) day, to allow him to visit his father, in the presence of [REDACTED],

at [REDACTED].15
