I. INTRODUCTION

1. As foreshadowed,¹ pursuant to Article 40 of the Law² and Rule 118(2) of the Rules,³ the Specialist Prosecutor's Office ('SPO') requests leave to amend the Exhibit List⁴ to include two items (comprising of six documents and totaling 12 pages)⁵ provided by W04403 on 17 and 20 March 2025 during his preparation session ('Requested Amendments'). The Requested Amendments consist of: (i) an official KLA General Staff Operational Directorate identification card, with W04403's name and photograph;⁶ (ii) W04403's 20 June 1999 signed request for demobilization from the KLA;⁻ (iii) a 25 June 1999 certificate signed by the Brigade 137 commander attesting W04403's handover of weapons;⁶ (iv) a 27 June 1999 KLA General Staff decision on W04403's demobilization, signed by Agim ÇEKU as Chief of the KLA General Staff;⁰ (v) an interview with W04403 published in the newspaper 'Kombi' on 8 July 1998;¹¹⁰ and (vi) an interview with W04403 published in 'Gazetë e re Shqiptare' on 2 March 1999.¹¹

- 2. The SPO requests an expedited briefing schedule to enable a decision before the testimony of W04403, who is anticipated to commence testimony on 24 March 2025.¹²
- 3. This request which, at this stage, solely concerns amendment of the Exhibit List and not admission¹³ is limited in scope, allows timely and effective Defence preparations, and concerns relevant material, which is probative of the charges.¹⁴

II. SUBMISSIONS

- 4. In this complex multi-Accused case, involving a considerable amount of evidence, amendments to the Exhibit List should be treated with flexibility, provided that as is the case here there is adequate protection of the Accused's rights.¹⁵
- 5. As detailed below, the Requested Amendments are relevant to W04403's evidence and known aspects of the SPO's case, including W04403's role and involvement in the KLA, and the KLA General Staff's structure and authority:

- a. Exhibit 4 is an official KLA General Staff Operational Directorate identification card, with W04403's name and a photograph of W04403 wearing a beret with the KLA insignia. The identification card bears the typewritten 'KLA Operational Directorate' header, and the seal of the KLA Operational Directorate superimposed on the KLA insignia. It also bears the signature of a commander. In W04403's statements, which the Panel has declared admissible under Rule 154 ('Rule 154 Statement'), W04403 discusses his appointment to the Operational Directorate, the functions of this directorate and his personal involvement and role. During witness preparation, W04403 stated he received this document in December 1998.
- b. Exhibit 1 is a typewritten request dated 20 June 1999, signed by W04403 and addressed to the Chief of the KLA General Staff.¹⁹ W04403 notes he has been a KLA member since 8 March 1998 and requests an order for his demobilization from the KLA ranks. In his Rule 154 Statement, W04403 provides information on his request for demobilization and the time and circumstances in which he joined the KLA.²⁰
- c. Exhibit 3 is a document bearing the header of the KLA Dukagjini Operational Zone Brigade 137 'Gjakova', with a handwritten certificate provided to W04403 when he handed over his automatic rifle to the Brigade 137 commander in Gjakova. It is dated 25 June 1999 and signed by

commander Avdullah BABALIA. In his Rule 154 Statement, W04403 refers to personally surrendering his weapons in Gjakova.²¹

- d. Exhibit 2 is a typewritten document bearing the KLA General Staff header, Agim ÇEKU's signature—as Chief of the KLA General Staff—and the KLA General Staff seal. It contains the 'Decision' on W04403's demobilization from the KLA ranks, which was issued pursuant to the Internal Regulations of the KLA General Staff.²² The decision, dated 27 June 1999, indicates that W04403's demobilization would be effective as of 1 July 1999. In his Rule 154 Statement, W04403 refers to being formally demobilized by order of Agim ÇEKU as of 1 July 1999 and that the relevant decision was given to him in person by Agim ÇEKU on 1 July 1999 in Peja.²³ The circumstances of W04403's demobilization are also discussed in the book 'Dialogue with Naim MALOKU (MALJOKU)'.²⁴
- e. Exhibit 10 contains an interview with W04403 published in the newspaper 'Kombi' on 8 July 1998. In the article, asked which of Kosovo's political leaders he valued the most and would trust to sit at a negotiating table, W04403 responded in favour of RUGOVA.²⁵ W04403 clarified in the interview that this was his personal belief while the General Staff and the KLA spokesperson are those who spoke on behalf of the KLA. In the interview, W04403 also spoke of his role in the KLA and of the KLA's structure and organisation. During the witness preparation session, W04403 stated that Hashim THAÇI had a copy of this Kombi interview when, on 22 or 23 August 1998, in Kleçkë/Klečka, he told W04403 that he

did not agree with things he had said in the interview.²⁶ On a later occasion, THAÇI told W04403: 'enough with interviews'.²⁷

- f. Exhibit 5 is an interview with W04403 published in *Gazetë e re Shqiptare* on 2 March 1999. In the interview, W04403 discusses several topics, including the Rambouillet Conference, Adem DEMAÇI's appointment by the KLA General Staff, the institutionalisation of the KLA, and his views on Ibrahim RUGOVA. A KLA Intelligence Sector report from the Dukagjini Operational Zone dated 16 March 1999, two weeks after this interview, reports, *inter alia*, that W04403 'has adopted a pro-government stance and has praised Rugova's policy' in interviews to newspapers, such as 'Gazeta Shqiptar'.²⁸
- 6. Accordingly, the Requested Amendments are relevant and of sufficient importance to justify their addition to the Exhibit List. This request is also timely, as the documents were provided by W04403 on 17 and 20 March 2025,²⁹ translated and addressed during the preparation session.³⁰ Thereafter, the SPO promptly filed this request.
- 7. Finally, no undue prejudice would result from adding these documents to the Exhibit List. The Requested Amendments total 12 pages, relate to known aspects of the witness's Rule 154 Statement and the SPO's case, and are of similar nature to other documents disclosed by the SPO and already on the Exhibit List.³¹

III. CLASSIFICATION

8. This filing is confidential in accordance with Rule 82(4) and as W04403's identity as a witness is not public at this time. Exceptionally, and considering that W04403 is anticipated to commence his testimony imminently, the SPO does not intend to file a public redacted version of this request. Instead, considering that W04403 does not have protective measures, the filing can be reclassified as public following the commencement of his testimony.

IV. RELIEF REQUESTED

9. For the foregoing reasons, the SPO requests that the Panel: (i) order an expedited briefing schedule to facilitate a decision before W04403's testimony commences; (ii) authorise the Requested Amendments; and (iii) reclassify this request as public following commencement of W04403's testimony.
