

Pursuant to the Oral Order<sup>1</sup> and following receipt of the relevant official transcript, the Specialist Prosecutor's Office ('SPO') sent *inter partes* the proposed lesser redacted transcripts for all private session testimony of W04745. On 17 March 2025, Victims' Counsel sent his response agreeing with the SPO's proposed redactions for W04745. On 19 March 2025, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing additional redactions to the testimony of W04745. The Defence teams did not respond. The SPO has consolidated all proposed redactions and related justifications in Annex 1.<sup>2</sup>
