1. On 24 March 2025, the Specialist Prosecutor's Office ('SPO') filed a consolidated motion for the admission of evidence pursuant to Rules 153 and 155.¹ Annex 5 to Filing F03056 contained parts of W04754's Rule 153 Statement with proposed redactions marked; such redactions were also indicated at paragraph 35, footnote 70 of Filing F03056.²

2. Annex 5, inadvertently, did not include Part 9 of W04754's SPO interview.³ The SPO thus provides a complete and corrected version, which now also includes the proposed redactions to Part 9.⁴ Further, the redactions indicated in footnote 70 of Filing F03056 should also contain reference to 083524-TR-ET Part 5 RED2, p.18, lines 4-9.

3. As lesser redacted versions of the Rule 153 statement have now been disclosed, the SPO also requests that they replace the versions tendered in Filing F03056.⁵
