- 1. The Registrar hereby brings the following information to the Single Judge's attention, with regard to the legal representation of Mr Haxhi Shala ('Mr Shala').
- 2. On 4 February 2025, the Trial Panel decided, *inter alia*, to approve the plea agreement which Mr Shala entered into with the Specialist Prosecutor's Office.<sup>1</sup>
