1. At this stage, having reviewed the evidence admitted, and in the interest of facilitating the fairness and expeditiousness of the proceedings, the Specialist Prosecutor's Office ('SPO') hereby provides notice that it is no longer relying upon the following, discrete allegations in the Indictment:¹

- a. The detention and mistreatment at [REDACTED], Ferizaj/Uroševac;²
- b. The murder of [REDACTED];³
- c. That Jakup KRASNIQI was present and visited the room where detainees were being held in Malishevë/ Mališevo;⁴
- d. That Rexhep SELIMI threatened [REDACTED] in October 1998,⁵ and
- e. [REDACTED].⁶
- 2. The SPO additionally clarifies that [REDACTED] and [REDACTED]⁷ refer to the same person, rather than two separate people.
- 3. This filing is confidential pursuant to Rule 82(4) of the Rules.⁸
