

## Prosecution submissions pursuant to Order F00287

1. Pursuant to Order F00287,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') confirms that the information identified by the Pre-Trial Judge can remain available to the Accused.<sup>2</sup>

2. The SPO further confirms that the *ex parte* markings of filings F00170, F00171, F00175, and F00201 can be lifted and the filings can be made available to all Accused.<sup>3</sup>

3. Finally, the SPO will make the necessary reclassification request before the Court of Appeals Panel in due course.<sup>4</sup>

4. This filing is filed as strictly confidential and *ex parte* pursuant to Rule 82(4) of the Rules.<sup>5</sup> The SPO requests its reclassification to confidential and/or public when considered appropriate by the Pre-Trial Judge.
