
1. Pursuant to Decision F00254,¹ the Specialist Prosecutor's Office ('SPO') hereby reports to the Pre-Trial Judge that on 23 April 2025 it received from [REDACTED] an Excel document containing (a) basic device information ('Category A') and (b) non-content summary information ('Category B') from the [REDACTED]² seized from Hajredin KUÇI on 5 December 2024 (the 'KUÇI Phone'). The SPO has registered the Excel document in the SPO's evidence collection repository and will store the information in accordance with the Rules.³ The information provided by [REDACTED] included the following results:

2. The SPO notes that the information provided by [REDACTED] summarising the (above-cited) basic volume of certain content of the KUÇI Phone indicates that the phone may contain relevant content. Accordingly, and as recently forecast in Filing F00273,⁴ the SPO will rely on the results of the basic, non-content information to inform the SPO's upcoming submissions regarding search queries to be executed by the Independent Counsel, once appointed.
