

1. As foreshadowed *inter partes*,¹ consistent with the standard review procedure² and following receipt of the relevant official transcript, the Specialist Prosecutor's Office ('SPO') sent *inter partes* its proposal relating to the classification of W04419's testimony transcripts. On 15 May 2025, the Witness Protection and Support Office ('WPSO') sent its response agreeing with the SPO's redactions and proposing specific redactions. On 19 May 2025, Victims' Counsel sent his response indicating that he had no proposals to the transcript. The Defence teams did not respond. The SPO has consolidated all proposed redactions and related justifications in Annex 1.³

2. Annex 1 is confidential in accordance with Rule 82(4) and to give effect to existing protective measures.
