1. Pursuant to Rule 82 of the Rules,¹ the Specialist Prosecutor's Office ('SPO') requests reclassification of F00014/A01, F00455/A03, F00455/A04, F00455/A05, F00663/A01, and F01000/A01 as confidential.² The remaining redactions in the confidential redacted versions of these Rule 86(3)(b) Outlines and Rule 109(c) Charts³ are no longer justified for the same reasons given previously in relation to the Pre-Trial Brief.⁴

2. The SPO also submits a confidential lesser redacted version of the First Rule 86(3)(b) Outline.⁵ The limited, remaining redactions to certain pseudonyms and ERNs

4. Confidential classification of the redacted version of the First Rule 86(3)(b) Outline at Annex 1 and the other Rule 86(3)(b) Outlines and Rule 109(c) Charts remains necessary to give effect to existing protective measures.
