I. INTRODUCTION

1. Pursuant to Article 22(1) and (6) of the Law on Specialist Chambers and Specialist Prosecutor's Office (Law No. 05/L-053) ("Law"), and Rule 114(4)(a) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), Victims' Counsel notifies the Panel of the death of Victim 296/06 ("V296").

II. CLASSIFICATION

2. This submission is classified as public as it contains no identifying information. The Annex identifies the victim concerned and should remain confidential.

III. PROCEDURAL HISTORY

3. V296 was admitted to participate in the proceedings as a victim on 21 April 2021 as a result of having suffered mental harm as an indirect victim of imprisonment/illegal or arbitrary arrest, detention, other inhumane acts or cruel treatment, murder, and enforced disappearance.¹
4. V296 also had the status of a witness in this case.²

IV. SUBMISSIONS

5. Victims' Counsel has been informed by a relation that V296 has passed away. A copy of the death certificate was provided by V296's family and is annexed to this filing.³ At present, Victims' Counsel has not been informed of any close relation wishing to resume V296's action.

V. CONCLUSION

6. Victims' Counsel hereby informs the Panel of V296's death.
