I. INTRODUCTION

1. The Defence for Messrs. Hashim Thaçi, Kadri Veseli, Rexhep Selimi and Jakup

Krasniqi ("the Defence") hereby requests, pursuant to Rule 81, Rule 82(1) and (5) of

the Rules of Evidence and Procedure and Article 70 of the Registry Practice Direction

Files and Filings before the KSC, to access and use, on a confidential basis, confidential

filings and/or annexes from Prosecutor v. Pjetër Shala (Case KSC-BC-2020-04) and

Prosecutor v. Salih Mustafa (Case KSC-BC-2020-05).

2. The requested material is specifically identified, there is a legitimate forensic

purpose for the request and would facilitate fair and expeditious proceedings in *Thaçi*

et al. Access to the requested material is necessary for the Defence to be able to

effectively prepare the response to F03160 "Victims' Counsel's submission of expert

reports with a request to admit them into evidence" due on 9 June 2025, and more

generally the upcoming Victims' case.

3. This request should have no impact on applicable protective measures which

shall continue to have effect in Thaçi et al. Any reference to or use of confidential

portions of the filings would occur on a confidential basis.

II. SUBMISSIONS

4. International Tribunals have held that a party is entitled to seek material from

any source, including another case before the Tribunal, to assist in the preparation of

its case.² The material sought should be specifically identified and the applicant

seeking access to confidential material must demonstrate a legitimate forensic

purpose.³ In this regard, consideration should be given to the relevance of the material sought which may be demonstrated by showing the existence of a nexus between the applicant's case and the case from which such material is sought and that this material is likely to assist his case materially or that there is at least a good chance that it would.⁴ The Trial Panel assessed the request in light of "the Defence's right to receive all material and relevant evidence or facts, pursuant to Article 21(6), and the need to ensure the protection of victims and witnesses, pursuant to Article 23" and held that the Panel had discretion to grant access to parts of the record of a closed or completed case.⁵

- 5. Victims' Counsel, in *Thaçi et al.* submitted reports which were already admitted in other cases: one iMMO report from Case 04 and two iMMO reports from Case 05 as well as one report authored by Dr Lerz in Case 04 and one in Case 05 ("Expert Reports").⁶ Victims' Counsel requested the Panel to admit them into evidence.⁷
- 6. The iMMO Reports in Case 05 concern the physical and psychological harm suffered by V08/05 [REDACTED] and V09/05 [REDACTED] whereas the Report in Case 04 concerns the physical and psychological harm suffered by V01/04 [REDACTED].⁸ The report prepared by Dr Lerz in Case 04 concerns all of the VPPs in that case. With regard to V01/04 [REDACTED], Dr Lerz gives a calculation that

provides an estimate for his loss of income as a result of his inability to work. The

report prepared by Dr Lerz in Case 05 concerns the loss of income and/or loss of

opportunities suffered by V08/05 [REDACTED], V09/05 [REDACTED], and V10/05

[REDACTED] due to the harm that they allegedly suffered.9

7. The Defence is entitled to access the confidential filings and/or annexes related

to the Expert Reports. The arguments put by the Parties and reasoning applied in

those cases are relevant for the Defence in Case 06. The overlap between Case 06 and

Cases 04 and 05 is obvious and was already acknowledged by the Panel. 10 The crimes

for which Mr. Shala and Mr. Mustafa were charged are identical to the temporal and

geographical scope as those with which the Accused are charged. Also, the Accused

have been charged under the Joint Criminal Entreprise ("JCE") mode of liability

within the temporal period of March 1998 through September 1999 and within the

context of the same alleged armed conflict between the KLA and FRY forces. The

Defence and SPO previously requested for the Thaçi et al. Panel, Parties and Victims'

Counsel to access and use confidential filings from Case 04 and Case 05 and the

requests were granted.11 In the present case, the Expert Reports relate to Victims

participating in the proceedings in Case 06.

8. The Defence submits that the requested material is sufficiently identified as it

only relates to thirteen specific filings or annexes, has a legitimate forensic purpose

considering the factual nexus between the cases and that the requested material will

assist the Defence materially.
